### How to Enter

School nutrition professionals or employees employed by a school district or school nutrition operation, who submit the online form on [www.school.nutrition.org/nslw](http://www.school.nutrition.org/nslw), are automatically entered into the prize drawing. There is no separate entry form for the drawing. No responsibility is assumed by SNA, and entrants waive all claims for lost, late, illegible or misdirected entries; or for any problems of technical malfunction of any telephone network or lines, computer equipment, software, failure of any internet service provider or any combination thereof including without limitation any damage to entrant's or any other person's computer resulting from participation in this promotion.
