



## STEPS Challenge Prizes 2017-2018

#### How to Enter

STEPS Challenge prize winners will be drawn at random on May 9, 2018. To enter the random prize drawing, STEPS challenge participants must be registered users, and have participated in *at least* one monthly challenge. There is no separate entry form; every STEPS participant that submitted points for a monthly challenge is automatically entered in the drawing.

#### Prizes

A prize drawing will be conducted in May 2018 from the pool of STEPS Challenge monthly challenge participants. One (1) winner will receive the grand prize: an all-expenses paid trip to attend ANC 2018 in Atlanta. **The prize includes: airfare, hotel stay, two conference registrations, \$500 spending money, and VIP 'extras'.**

**Five (5) other prizes will be given to random winners.** These prizes include: an REI gift card, a Whole Foods gift card, a Healthy Surprise box, a FitBit wristband, and a Spafinder giftcard.
