Each picture/action alert response will qualify **one person for one entry**. The SNA member that submits the picture will qualify for entry. All persons in the picture must have provided consent. ### LAC 2018 Sweepstakes Entry

## Prize Drawing

The winner selected by a panel of SNA staff judges following the submission deadline of **November 27<sup>th</sup>, 2017**. The winner will be notified by email within 5 business days of drawing date. A prize winner may choose to decline the prize upon notification if he/she so wishes. If SNA is unable to contact potential winner by email or if any potential winner fails to respond to the prize notification within 7 days of issuance of notification or if any winner fails to comply with any of the requirements, an alternate winner shall be selected through another random drawing. If, in SNA's opinion, there is any suspected or actual evidence of electronic or non-electronic tampering with any portion of the contest, or if technical difficulties compromise the integrity of the promotion, SNA reserves the right to terminate the promotion and conduct a random drawing to award LAC registrations using all currently eligible entries received as of the termination date.
