## 2020 SNA Legislative Action Conference Sweepstakes: Complete Rules and Consumer Disclosures

### Terms

The School Nutrition Association (SNA) will select one **(1) winner** via a random drawing. SNA members are eligible for random selection once evidence of an invitation or a site visit from a current member of the United States Congress (U.S. Senate or U.S. House of Representatives) has been submitted to [advocacy@schoolnutrition.org](mailto:advocacy@schoolnutrition.org). Proof includes – but is not limited to – photos, news articles, press releases, or videos. An individual submission will qualify one (1) person for one (1) entry. Each visit or invitation qualifies as **one (1) entry**; therefore, members are limited to and may only submit **one (1) entry** per site visit or invitation. Entries will only be accepted for visits or invitations that have been sent or occurred after September 26, 2019. A follow-up visit from a legislator is not necessary to enter; only proof of an invitation is required.
