- Determine most pressing concerns and needs of SN operators as they feed kids during Coronavirus-related closures

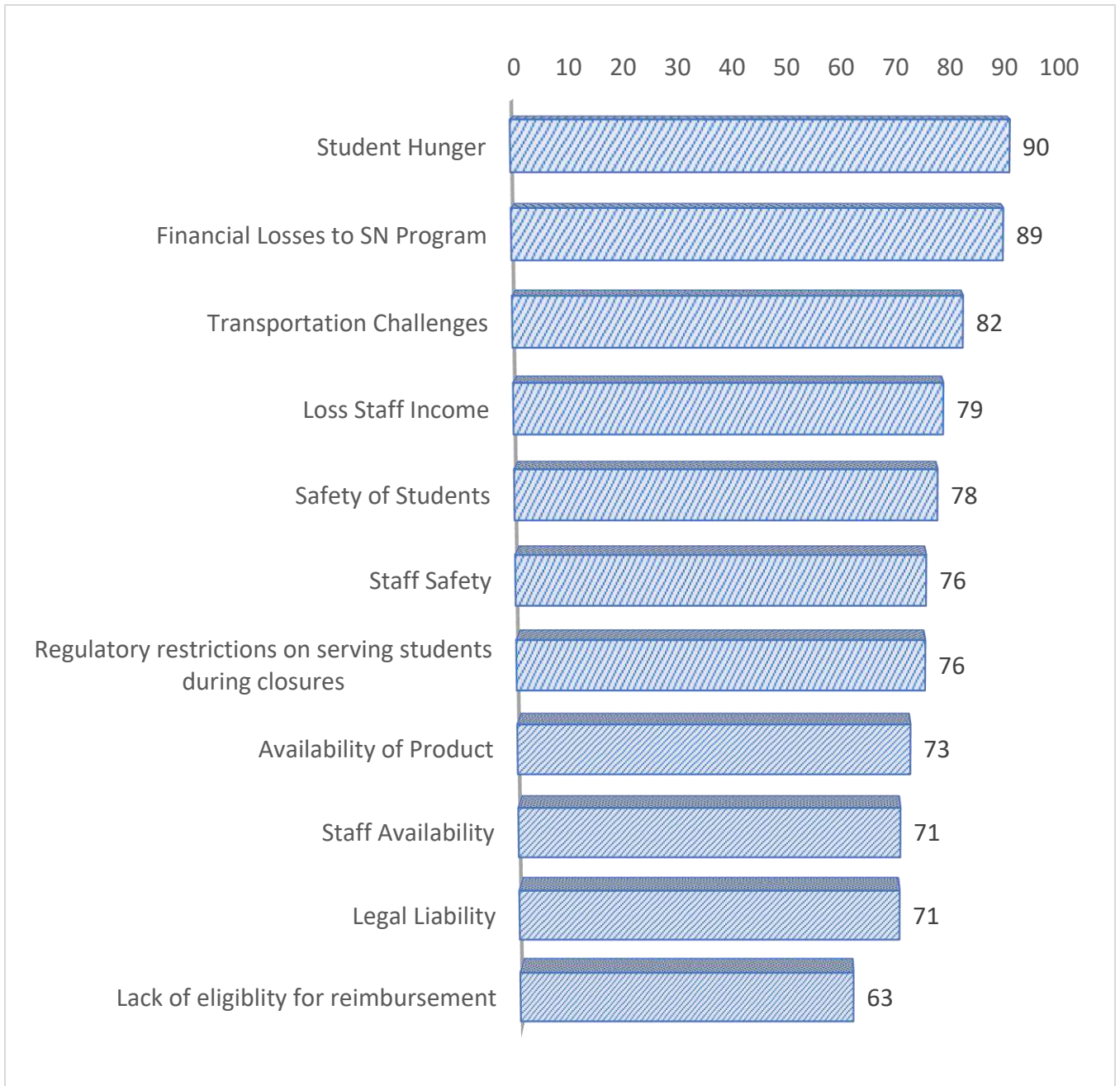

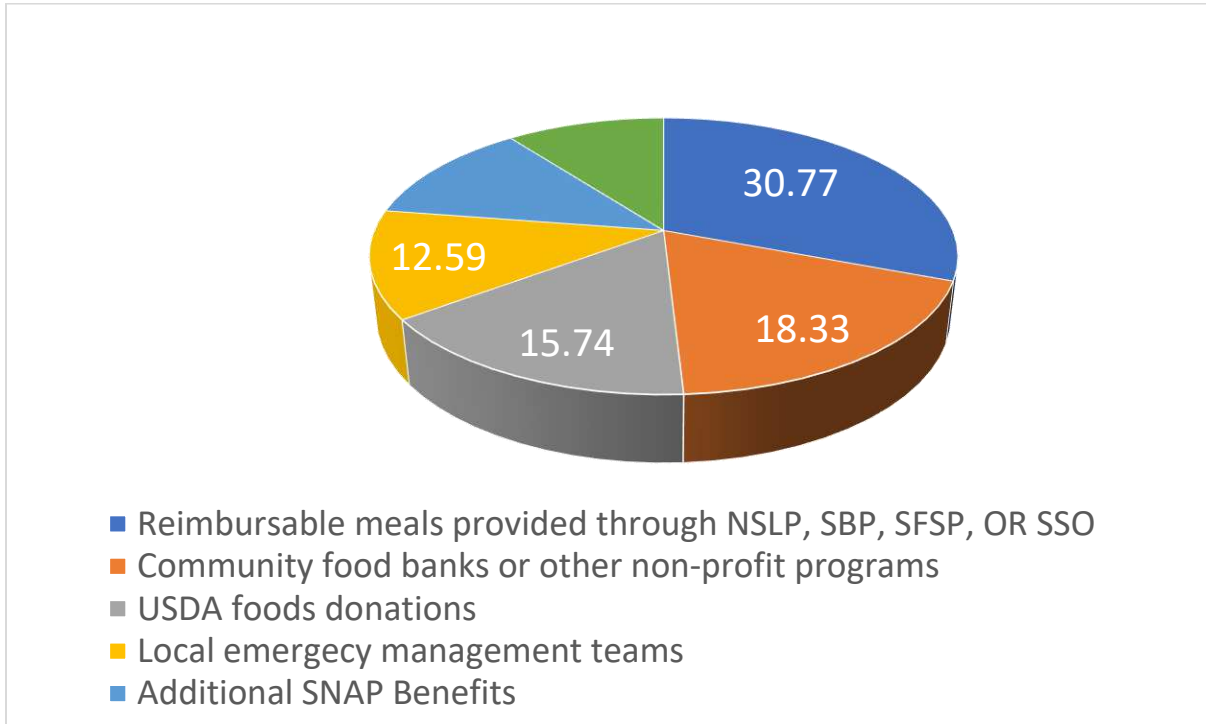
