# **2024 SNA Position Paper and Trends Survey**

## **Complete Sweepstakes Rules**

## **How to Enter**

SNA members who are employed by a school district or school nutrition program and complete either the 2024 Position Paper Survey (non-directors) or the 2024 Position Paper and Trends Survey (Directors/Supervisors) will be automatically entered into a randomized drawing to win one (1) free registration to LAC24. There is no separate entry form for the drawing. No responsibility is assumed by SNA, and entrants waive all claims for lost, late, illegible or misdirected entries or for any problems of technical malfunction of any telephone network or lines, computer equipment, software, failure of any internet service provider or any combination thereof including without limitation any damage to entrant's or any other person's computer, smartphone, or tablet resulting from participation in this promotion.
