#### **Membership Overview**

The July Membership Report shows that we have 46,032 members, which is 1,147 less than June 2025, 1,628 less than July 2024 and 1,520 less than May 2025 year-end total. Overall membership numbers are mostly following the normal seasonal patterns and the large decrease in members is attributed to larger SDMs reducing the size of their rosters due to budget constraints.

The Mid-Atlantic region is the only area showing an increase compared to last year, although the decreases are small in the



Western and Southeast regions. The Midwest and Southwest regions are showing the largest decline.

Since May 2025 year-end, the combined director categories show a small decrease. The biggest decreases in membership are in the Employee category which is down 1,050 members.

#### **Membership Trends**

Membership numbers generally decline during the summer vacation months and the winter and then bounce back in the fall and spring. Membership numbers decreased significantly during the COVID-19 pandemic and although there has been some recovery, overall membership numbers are below 2009 recession levels.

#### **School District Membership (SDM)**

The total number of SDMs for July 2025 is 31,760, which is 542 less than the May 2025 year-end total. SDMs currently account for 69.0% of the total membership. The chart below shows the top 10 SDM states.

Guidelines to determine Membership Division Champions require that although one state may be ranked #1 in both categories at time of report, awards will be given to the top 2 ranking states in each division, one for increase in the number of members and one for percentage increase. States must reach their annual membership goal to be eligible for the Division Champion Award. Awards are also given to states which increase membership and achieve the annual membership goal.
